CITY ORDINANCE NO. 2003-070

AN ORDINANCE AMENDING ARTICLE C, SECTION 6C.01(a) OF MAKATI CITY ORDINANCE NO. 2001-049 SO AS TO ADJUST THE RATES OF FEES FOR THE USE OF THE ARTIST PAVILION, MAKATI PARK AND GARDEN, BARANGAY WEST REMBO, MAKATI CITY, METRO MANILA, SUBJECT TO ALL LAWS AND EXISTING LEGAL RULES AND REGULATIONS.

WHEREAS, pursuant to City Ordinance No. 2001-049, Makati City is collecting fees for the use of its physical facilities, including the Artist Pavilion located at the Makati Park and Garden which has become a favorite venue for social activities and receptions, such as wedding, birthdays, etc.;

WHEREAS, at present, Makati City only charges minimal fees for the use of the Artist Pavilion which are very low based on the prevailing industry standard. The fees barely cover the electric consumption and basic maintenance requirements of the facilities, without margin of profit to cover repair and renovation caused by the ordinary and extra-ordinary wear and tear on the facility;

WHEREAS, to make the facility viable insofar as it will no longer be dependent to the city government for new funding for its maintenance, repairs and renovations, it is deemed necessary to adjust the rates collectible for the use thereof.

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED BY THE SANGGUNIANG PANLUNGSOD OF MAKATI, METRO MANILA, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:

Section 1. Article C, Section 6C.01(a) of Makati City Ordinance No. 2001-049 is hereby amended. The new rate of fees for the use of the Artist Pavilion at Makati Park and Garden shall be as follows:

2. Debut, Anniversary, Baptism, Birthday			
(a) Non-resident	P7,000	4 hrs.	P2,000/hr
(b) Resident	5,000		1,000/hr
3. Makati City School/Office Official activities, such as reunions beauty contest, Christmas party, get together, seminar, etc.			
(a) Non-Resident	P4,000	4 hrs.	P1,000/hr
(b) Resident	2,000		500/hr

Section 2. Let copy of this Ordinance be furnished the Makati Park and Garden Administration and the City Treasurer for their information and guidance.

Section 3. This ordinance shall take effect upon its approval.
