**AN ORDINANCE ENACTING THE MAKATI CITY TRAFFIC CODE,  
SUBJECT TO ALL LAWS AND EXISTING LEGAL RULES AND  
REGULATIONS.**

**WHEREAS**, the City Government of Makati, pursuant to Section 458(5)(v-vi) of the Local Government Code, is authorized to regulate traffic within its territorial jurisdiction, to the exclusion of other entitles/agencies of the government;

**WHEREAS**, the proposed Traffic Code is a product of consultation with other LGUs in Metro Manila which agreed to come up with a uniform traffic code for adoption by local government units in Metro Manila area. Various stakeholders were also consulted in a public hearing held for the purpose;

**NOW THEREFORE, BE IT ENACTED AS IT IS HEREBY ENACTED BY THE SANGGUNIANG PANLUNGSOD OF MAKATI, METRO MANILA, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:**

**Section 1.** The Makati City Traffic Code, which is hereto attached as Annex “A”, is hereby enacted, subject to all laws and existing legal rules and regulations.

**Section 2.** If any part or provision of this Ordinance is declared invalid or illegal other parts or provisions not so affected shall remain valid and effective. This also repeals or amends any existing ordinance inconsistent herewith.

**Section 3.** This Ordinance shall take effect after its approval by the Sangguniang Panlungsod and the City Mayor, and fifteen (15) days following its publication in a newspaper of general circulation.
