AN ORDINANCE APPROPRIATING P12M OR SO MUCH THEREOF AS MAY BE NECESSARY TO BE MADE AVAILABLE FOR THE PROPOSED COMPLETION OF CONSTRUCTION OF SWIMMING POOL FACILITIES AT MAKATI PARK AND GARDEN (MAKATI AQUA SPORTS CENTER), LOCATED AT J.P. RIZAL EXTENSION, BARANGAY WEST REMBO, MAKATI CITY, METRO MANILA, FUND SHALL BE TAKEN FROM THE EXECUTIVE BUDGET CY 2006 UNDER THE CAPITAL OUTLAY OF THE OFFICE OF THE VICE MAYOR AND FURTHER AUTHORIZING THE HONORABLE MAYOR JEJOMAR C. BINAY TO ENTER INTO A CONTRACT WITH THE EXISTING CONTRACTOR, SUBJECT TO ALL LAWS AND AUDITING RULES AND PROCEDURES.

WHEREAS, the swimming pool facilities at Makati Park and Garden (Makati Aqua Sports Center), located at J.P. Rizal Extension, Barangay West Rembo, Makati City is one of the projects scheduled in the calendar of activities of the City Engineering Department for CY 2006;

WHEREAS, the project will further strengthen health and well being of its residents and constituents;

WHEREAS, there is available fund sufficient to finance the said project in the Executive Budget CY 2006 under the Capital Outlay of the Office of the Vice Mayor;

NOW THEREFORE, BE IT ENACTED AS IT IS HEREBY ENACTED BY THE SANGGUNIANG PANLUNGSOD OF MAKATI, METRO MANILA, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:

Section 1. The amount of P12M or so much thereof as may be necessary to be made available is hereby appropriated for the proposed completion of construction of swimming pool facilities at Makati Park and Garden (Makati Aqua Sports Center), located at J.P. Rizal Extension, Barangay West Rembo, Makati City, Metro Manila, fund shall be taken from the Executive Budget CY 2006 under the Capital Outlay of the Office of the Vice Mayor and further authorizing the Honorable Mayor Jejomar C. Binay to enter into a contract with the existing contractor, subject to all laws and auditing rules and procedures.

Section 2. Let copy of this Ordinance be furnished the City Engineering Department, the City Treasurer's Office, the City Budget Office and other concerned offices for their information, guidance and reference.

Section 3. This Ordinance shall take effect immediately upon its approval.
