A RESOLUTION AMENDING CITY RESOLUTION NO. 2002-061
BY ADJUSTING THE AMOUNT OF BURIAL ASSISTANCE
GRANTED THEREUNDER FROM P4,000.00 TO P3,000.00,
SUBJECT TO ALL LEGAL AND AUDITING RULES AND
PROCEDURES.

WHEREAS, to complement its existing burial assistance programs, the City of Makati, through City Resolution No. 2002-061, granted P4,000.00 burial assistance to families of decedents 60 years old and above, with funds to be taken from the Special Activities Fund (SAF) of the Office of the Mayor CY2002;

WHEREAS, to stretch out the limited allocation for the project, with the end in view of greater number of beneficiaries, an adjustment in the amount of burial assistance granted under the resolution is hereby proposed.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MAKATI, METRO MANILA, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:

Section 1. City Resolution No. 2002-061 is hereby amended. Accordingly, burial assistance granted thereunder is hereby adjusted from Four Thousand Pesos (P4,000.00) to Three Thousand Pesos (P3,000.00), subject to all legal and auditing rules and procedures.

Section 2. Let copy of this Resolution be furnished the City Treasurer, OSCA and the Budget Officer for their information and guidance.

Section 3. This Resolution shall take effect immediately upon its approval.
